## The Corporate Insolvency (Insolvency Practitioner Accreditation) Regulations, 2019

ARRANGEMENT OF REGULATIONS

## Regulation

- 1. Title
- 2. Grant or rejection of application
- 3. Terms and conditions attaching to accreditation number and accreditation certificate
- 4. Renewal of accreditation
- 5. Publication of names of accredited insolvency practitioners

IN EXERCISE of the powers contained in section 179 of the Corporate Insolvency Act, 2017, the following Regulations are made:

1. These Regulations may be cited as the Corporate Insolvency (Insolvency Practitioner Accreditation) Regulations, 2019.

Title

2. (1) A person who wishes to practice as an insolvency practioner shall apply for accreditation or renewal of accreditation as an insolvency practioner in the form set out schedule, on payment of the fee set out in the Corporate Insolvency (Form and Fees) Regulations, 2019.

Grant or rejection of application for accreditation

SI. No. of 2019

- (2) The Registrar shall, within foruteen days of receipt of an application for accreditation—
  - (a) grant accreditation where the applicant meets the requirements; or
  - (b) reject the application where the applicant does not meet the requirements.
- (3) The Registrar shall, where the Registrar rejects an application in accordance with sub-regulation (2)(b), inform the applicant of the reasons for rejection.
  - 3. An accredited insolvency practioner shall—

Terms and conditions attaching to accreditation number and accreditation certificate

- (a) reflect the accreditation number on documents generated by that insolvency practioner; and .
- (b) display the accreditation certificate at a conspicuous place at the practitioner's usual place of business.

Renewal of accreditation

- 4. (1) An insolvency practioner may apply for renewal of accreditation with the Registrar three months before the expiry of the current accreditation.
- (2) The Registrar may approve or reject an application for renewal of accreditation.
- (3) The Registrar may reject an application for renewal or accreditation where the Registrar determines that the requirements of the Act have not been met.
- (4) The Registrar shall furnish the applicant with resons for rejecting an application for renewal, and where possible, request the applicant to remedy the cause of the rejection within a specific period.
- 5. The Registra shall publish annually in the *Gazette*, and on the Agency's website or in a daily newspaper of general circulation, the names and addresses of accredited insolvency practitioners.
