The Companies (Fees) Regulations, 2019

IN EXERCISE of the powers contained in section 374 of the Companies Act, 2017, the following Regulations are made:

- 1. These Regulations may be cited as the Companies (Fees) Title Regulations, 2019.
- 2. The fees set out in the Schedule are payable in respect of Fees the matters specified therein.
- 3. The Companies (Fees) Regulations, 1995, are revoked.
