




NOTICE IS HEREBY GIVEN, that any person who has grounds of opposition to registration of the following trade marks may, within two months of the date of publication hereof, file a notice of opposition on Form TM No. 6 with the Registrar & CEO, at the IP Office.

Preferably, any objector must file the notice of opposition only after writing the applicant to give him reasonable notice about the intended opposition in order to afford him an opportunity of withdrawing his application. Failure to do this will be taken into account in considering any application by any party for an order for costs if the opposition is uncontested by the applicant.

A letter B, C or D prefixed to the application number means that the application is for registration, respectively, in Part B, C (Certification mark) or D (defensive mark) of the register of trade marks. If an application proceeds in Part A, the application is unaccompanied by any letter.





























