The Companies (Fees) Regulations, 2022

IN EXERCISE of the powers contained in sections 374 of the Companies Act, 2017, the following Regulations are made:

1. (1) These Regulations may be cited as the Companies (Fees) Regulations, 2022.

Title and commencement

- (2) These Regulations shall come into operation on 1st January, 2023.
- 2. The fees set out in the Schedule are payable in respect of the matters specified in that Schedule.
 - 3. The Companies (Fee) Regulations, 2019, are revoked.
