NOTICE IS HEREBY GIVEN, that any person who has ground of opposition to registration of the following trade marks may, within two months of the date of publication hereof, file a notice of opposition on Form T.M. No. 6 with the Registrar of Trade Marks, Zambia Patent Office.

Preferably, any objector must file the notice of opposition only after writing the applicant to give him reasonable notice about the intended opposition in order to afford him an opportunity of withdrawing his application.
