NOTICE IS HEREBY GIVEN, that any person who has ground of opposition to registration of the following trade marks may, within two months of the date of publication hereof, file a notice of opposition on Form T.M. No. 6 with the Registrar of Trade Marks, Zambia Patent Office.

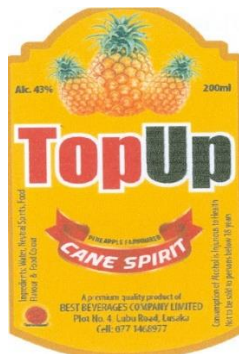

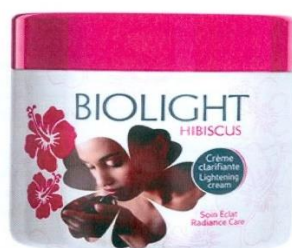

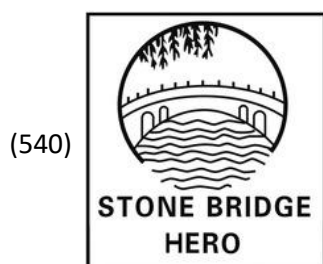
